

Sir,

I the undersigned have the honour to state that on 03/05/2023 at about 7:30 pm, some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki community from different villages were entered at Ekou Bazar village, Imphal East District, Manipur and started damaging properties and burning houses .

The following properties of my house were damaged in the incident.

1. One house (Pucca house Approx. 16 lakhs)
2. Paddy bags (30 no. of bags)
3. Cash (Rs. 7 Lakhs)
4. Gold (60 San Approx 9 lakh)
5. Domestic animals like 15 Hen, 100 Ducks, 5 Pigs, etc.
6. Documents (discharge certificate book, service ID card, P.P.O document, AGIF document, security training certificate, Ex-servicemen contributory health scheme card)
7. Other house hold Properties.

The above damages properties worth above 45 Lakhs. I therefore, request to kindly taken up further legal action against the above unknown persons.
