I have the honour to report that on 23/1/2023 stating that from 19/1/2023 to 22/1/2023 @ 9:00am to 6:00pm a joint team of Kangpokpi District Police led by ASP (Ops) KPI consisting of OC/KPI-PS, GSPM, NKM and personnel , a team of Imphal East Police, Senapati and IRB/MR personnel, NAB-Imphal, Range Forest Officers of Kangpokpi Forest and Senapati Forest with the villagers of Liangmei Naga Council, Makui Naga and Chawangking under the supervision of SP-Kangpokpi and DFO Kangpokpi conducted destruction of illicit poppy plantation at T. Khonomphai Hill Ranges under the chief ship of Mrs .Nengneichin Kipgen w/o (L) Henjathang Kipgen and her associates which destroyed approximately 190 Acres which was planted by breaking of land prohibited in the Protected forest land were completely destroyed.

It, is therefore, requested to take up further necessary legal action as per provision of law.
