Today i.e On 18/1/2023 at around 11:15 am, a joint team of Kangpokpi District police, NAB, MR/FRB and Forest Department, Kangpokpi, SDO Lhungtin block, Kangpokpi District, numbering about 273 (two hundred seventy three) persons led by Shri. Tholu Rocky, MPS Addl. SP(LD)/KPI and Insp. B. Lanthang Naiphei DC/Saikul-PS under the supervision of Shri. Th. Vikramjit Singh MPS, SP/KPI carried out a mass destruction of illicit poppy plants cultivation at Lhangrom hill ranges in the western part of Jangnai village under Lhungtin Sub-Division, Kangpokpi District, Manipur about 20kms North from Saikul Police station in which illegal poppy plantation of land covering about 50 (fifty) acres were totally destroyed.

It is therefore, requested to take up necessary legal action against the culprits involved in this illegal cultivation.
