





Subject: Report on Looting and Arson attacked at H. Molhoi Village, Saikul-  
Kangpokpi District.

Sir,

With, due respect I, **Thanglenmamg Lupheng** an army by profession, No.4386237W 8<sup>th</sup> Assam Regt. age about 24 year h/o **Tinkhohoi** Touthang belonging to any Kuki Tribe (ST) would like to state that I am a resident of H. Molhoi Village, P.O.&P.S Saikul, District Kangpokpi. presently staying at M.Songgel Village, Churachandpur and that on the 28<sup>th</sup> May 2023 at around 2:00 pm due to the ethnic clash in Manipur, Meitei miscreant suspected to be member of Arambai Tengol and Meitei Leepun coming from Khonomphai attacked our village, unable to resist such forces my villager are compelled to fled from our village for their own safety in such a manner that all our belonging and property were left behind.

That, the attacker started burning our village after firing several round from their automatic rifle and in the process my new pucca house (2- Bed Room) along with all my property was burnt to ashes causing much mental agony and material loss which may amount to a value of INR. 50,00,000/-(Rupees Fifty Lakhs only) inclusive of 2-Bed Room Semi-Pucca House, Furniture, Electronic Goods, Kitchen Ware, Clothing and Live Stock.

It may also mention that my Honda Activa 2017 Model was also burn in this arson.

And that, I am filing this report lately after coming home on leave as such I humbly pray that your kind office may accept my application and initiate necessary action at the earliest for the end of Justice.
