The properties that were burn down are as follows:

- cxxxiv. House- Rs. 1,10,000/-
- cxxxv. Furniture – Rs. 80,000/-
- cxxxvi. Utensil – Rs. 60,000/-
- cxxxvii. Garments – Rs. 1,20,000/-
- cxxxviii. Electronic – Rs. 35,000/-
- cxxxix. Cash – Rs. 50,000/-

Total approximate value is about Rs. 450,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
