



I the undersigned have the honour to state that on 03/05/2023 at around 7:30 P.M. Some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki community from different villages were entered at Ekou Bazar village Imphal East District, Manipur and started damaging properties and burning houses.

The following properties of my houses were damages in the incident.

1. One house (Semi Pucca house approx. 10 lakhs)
2. Paddy bags (30 no. of bags)
3. Cash (Rs 70 thousands)
4. Gold (7 San)
5. Circular saw mill machine (approx. 1.3 lakhs)
6. Sweing machine 4 (approx. 35 thousands)
7. Others house hold properties

The above damages properties worth above 17 Lakhs. I therefore, request to kindly taken up further legal action against the above unknown persons.
