I, Shri Ngaoni Dovei, Deputy Manager of the Manipur State Co-operative Bank Ltd., Kangpokpi Branch, Kangpokpi District, Manipur, beg to report herewith that Kangpokpi Branch of the Manipur State Cooperative Bank Ltd. was closed since 04/05/2023 till 10/07/2023 in view of the prevailing law and order situation in the State.

2. That, yesterday at around 11.30 A.M., I along with 2 (two) staff of the Branch, viz. (i) Mr. L. Haongam, Senior Account Assistant; and (ii) Mr. Lamginhao Chongloi, MTS opened our Kangpokpi Branch for providing banking services to the customers of the Branch.

3. That, when we opened the Branch, we came to know that the following properties of the Kangpokpi Branch of the MSCB Ltd. has been vandalized and looted by unknown miscreants thereby causing huge loss to the Branch:
