

Subject: Report.

Sir,

I am writing to report the recovery and subsequent submission of a cache of weapons and arms as part of an operation conducted by a joint team of 16 Assam Rifles and Police team of Kangpokpi Police Station, in accordance with the specific input received on 14th February, 2024.

On the aforementioned date, a specific input was shared by intelligent agency regarding the presence of unknown armed miscreants in the general area of North Changoubung village approximately 3 kms NW of Changoubung in Kangpokpi District, Manipur. In response to this information, a column consisting of one Officer, one Junior Commissioned Officer (JCO), and sixteen Other Ranks (OR) from 16 Assam Rifles and representative from Police team of Kangpokpi Police Station launched a search operation on the inter village road connecting Changoubung and North Changoubung village. The joint team of 16 Assam Rifles and Police team of Kangpokpi Police Station was launched at around 0730 hrs. At around 1100 hours a suspicious patch covered with foliage next to abandoned hut was found. The joint team removed cleared the area.

After conducting a meticulous search for over three hours, the following small arms and ammunition and explosives were successfully recovered at 1100 hours. However, no arrest or untoward incident occurred during the search operation.

- (a) 01 x Carbine Machine Gun
- (b) 01 x Carbine Machine Gun Magazine (Regd. No. RR7520 SAF-1972)
- (c) 01 x 7.62 SLR Magazine
- (d) 01 x No 36 Hand Grenade
- (e) 01 x Wood Piercing Shell (CS)
- (f) 01 x Local Made Pumpi

The recovered weapons & arms are being handed over to you for further necessary action.
