Sir,

Today i.e. On 21/1/2023 at around 10:15 am, a joint team of Kangpokpi District Police, NAB, MR/IRB, Forest Department and including Magistrate Lhungtin block, Kangpokpi District, numbering about 166 (one hundred and sixty six) persons led by Shri. Tholu Rocky, MPS Addl. SP(LO)/KPI and Insp. B. Lunthang Vaiphei OC/Saikul-PS under the supervision of Shri. Th. Vikramjit Singh MPS, SP/KPI carried out a mass destruction of illicit Poppy plants cultivation at hill ranges of Puleijang villages, under Lhungtin Sub-Division, Kangpokpi District, Manipur about 25 kms North from Saikul police station in which illegal Poppy plantation of land covering about 25 (twenty five) acres were totally destroyed.

It is therefore, requested to take up necessary legal action.
