The properties that were Vandalized are as follows:

- i. House Vandalized – Rs. 5,00,000/-
- ii. Fou Kot – Rs. 15,000/-
- iii. 30 bags Paddy – Rs. 9,000/-
- iv. Luxury Item Godrej – Rs. 1,50,000/-
- v. House Materials with Electronic items – Rs 1,80,000/-
- vi. Clothes – Rs 2,00,000/-
- vii. 6 Cows & 2 Bulls – Rs 80,000/-

Total approximate value is about Rs. 11,34,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
