With due respect and regards, I would like to lay down few lines before you for your kind knowledge and necessary action that, on the night of 3rd May, 2023 while I was at my relative house, at around 10:00 pm some unknown miscreants suspected to be Kuki community have burnt down all the houses in Ekou Bazar due to communal conflict in Manipur, in which my house which is located at Thangal bazar, Ekou, is also among them. All the household properties including my two wheeler scooty Jupiter and one Bicycle is also burnt down along with the house.

The list of properties burnt or destroyed are enclosed in the annexure. The approximate value of the loss properties as per own assessment is calculated at about Rs. 8,61,000/- (eight lakh sixty oen thousand only).

Due to lack of legal knowledge and since I am staying at outside Manipur due to family problem I could not report to the conmern authority in time.

It is, therefore, requested to kindly take up necessary legal action against the culprits according to law.
