Sir,

I have the honour to report that, on 05/05/2023 at around 7:00 pm, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house and completely burnt down my house which was located at Praslan Village, PO - Kalapahar, PS - Kangpokpi, District - Kangpokpi.

The properties that were burnt down are as follows:

- i. Semi- Pucca House – Rs 6,25,000/-
- ii. Household Items(Tv, Fridge, Wooden Beds, Sofa, Table, Chain, Utensils , Gas Stove, Cylinder, Clothing & Jeweleries) – Rs 3,15,000/-
- iii. 40 bags of Paddy – Rs 60,000/-
- iv. Documents (Certificates, Passbook, ATM card, Pan Card, Job Card & Aadhaar Card)

Total approximate value is about Rs. 10,00,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
