- iv. Wooden Planks Rs 80,000/-
- v. Paddy 40 bags Rs 60,000/-
- vi. Documents (Certificates, Marksheet, Passbook, ATM card, Pan Card, Job Card & Aadhaar Card)

Total approximate value is about Rs. 22,80,000/- approximately.
