Sir,

I have the honour to report that, on 05/05/2023 at around 7:00 pm, the large number of kuklis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house and completely burnt down my house which was located at Praslan Village, PO - Kalapahar, PS - Kangpokpl, District - Kangpokpl.

The properties that were burnt down are as follows:

- i. Semi- Pucca House - Rs 5,50,000/-
- ii. Household Items(Computer Printer Set, Tv, Fridge, Bed, Sofa, Table, Chairs, Battery, Car, Dining Table, Dressing Table, Almirah, Electrical/Electronics Items Utensils, Gas Stove, Cylinder etc.) - Rs 5,50,000/-
- iii. Paddy 60 bags - Rs 90,000/-
- iv. Cash - Rs 18,50,000/-
- v. Documents (Certificates, Marksheet, ATM card, Pan Card, Job Card, Ration Card & Aadhaar Card etc.)

Total approximate value is about Rs. 30,40,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
