I have the honour to report that, on 05/05/2023 at around 8:30 am, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house and completely burned down my house which is located Lengdaba Khun, Dalli village, PS - Kangpokpi, District - Kangpokpi.

The properties that were burned down are as follows:

1. Semi pucca house - Rs. 15,00,000/-
2. Sangoi (outdoor house) - Rs. 80,000/-
3. Sangoi (cow shed) - Rs. 30,000/-
4. 5 nos. of cow - Rs. 1,75,000/-
5. Grainary (bag 17) - Rs. 21,250/-
6. Gold (1 chain + 1 earring) - Rs. 1,05,000/-
7. Cash - Rs. 1,90,000/-
8. Furniture - Rs. 2,16,000/-
9. Garment - Rs. 80,000/-
10. Utensils - Rs. 80,000/-
11. TV set - Rs. 45,000/-
12. Gas set + 2 cylinder - Rs. 18,000/-
13. Iron godrej (Almirah) - Rs. 12,000/-
14. Construction kitchen materials - Rs. 38,000/-
15. Syntax - Rs. 7,000/-
16. Others - 50,000/-

Total approximate value is about Rs. 26,47,250/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
