Sir,

I have the honour to report that today, the 28th January, 2023 from 9:00 A.M. to 12:00 P.M. a joint team of Kangpokpi District Police led by Addl SP(Ops) and OC/KPI-PS, Kangpokpi Forest led by Range Forest Officer, Kangpokpi, NAB Imphal led by OC/NAB under the supervision of SP-Kangpokpi and DFO/Kangpokpi conducted destruction of illicit Poppy plants inside KK (Kanglatongbi Kangpokpi) reserved forest near Pukhri Chandraman about 2 Kms West of Makuli village under the jurisdiction of Kangpokpi Police Station in which illegal Poppy plantation of approximately 11.9 acres which were planted by breaking of land prohibited in the reserved forest land were completely destroyed.

It is therefore, requested kindly to take up further necessary legal action as per provision of law.
