Sub-Report

Sir,

Today i.e On 22/1/2023, at around 11:00 am, a joint team of Kangpokpi District police, NAB, MR/IRB, Forest Department and including Magistrate Lhungtin block, Kangpokpi District, numbering about 158 (one hundred and fifty eight) persons led by Shri. H. Basulal Singh Dy. CO, 2MR and SI Lalgoulen Singson of Saikul PS under the supervision of Shri. Ph. Vikramjit Singh MPS, SP/KPI carried out a mass destruction of illicit Poppy cultivation at hill ranges of Waichei village, under Lhungtin Sub-Division, Kangpokpi District, Manipur about 18 km East from Saikul Police Station, in which illegal Poppy cultivation of land covering about 35 (thirty five) acres were totally destroyed.

It is therefore, requested to take up necessary legal action.
