I have the honour to report that, on 05/05/2023 at around 5:30 pm, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house which was located at Lower Kalapahar, PS – Kangpokpi, District - Kangpokpi.

The properties that were Vandalized are as follows:

- i. House Vandalized – Rs. 4,00,000/-
- ii. Furniture – Rs. 2,00,000/-
- iii. Utensils – Rs. 60,000/-
- iv. Clothes/Garments – Rs. 1,00,000/-
- v. Electrical appliances – Rs 1,50,000/-
- vi. Jewellery – Rs 2,00,000/-
- vii. Gas Cylinder 2 nos. – Rs 7000/-
- viii. Gas Stove- Rs 3000/-
- ix. Water Tank(Syntex 2 Nos.) – Rs 7000/-

Total approximate value is about Rs. 11,07,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
