

Sir,

With due respect, I the undersigned have the honour to state the following few lines for your kind consideration and favourable sympathetic order please. That, I am an attorney holder of package No. MN04220, as issued by Chief Engineer/EO, Manipur State Rural Road Development Agency, Manipur which is recorded in the name M/S Hao Infrastructure, PWD, Govt, of Manipur. As a sub-contractor, I have almost completed the construction work of 200 ft bailey bridge over Iril river on the road from Saikul road to Hangoipat at Saikul Block of Kangpokpi District, Manipur in the month of March, 2023 under PMGSY. But, inauguration of this bridge is not yet performed due to present communal crisis.

In the meantime, on 11/01/2024 some unidentified persons suspected to be Kuki militants have completely broke down the said public Bailey bridge with the aim to disturb the crossing of general public. The incident came to know only when uploaded video for destruction/ demolish of the bridge in social media and published in newspaper. The actual cost of construction of the bridge is Rs. 415.69 lakhs.

It is therefore requested you to kindly take up strike necessary legal action against them for destruction/ demolish of public property.
