

And started damaging household properties and burning houses.

The venue of the arbitration proceedings shall be at New Delhi and shall be in English language. To the extent permitted by law, the arbitrator's award shall be final and binding and the award shall be enforceable in a competent court of law.

17 Continuing Obligation

Any rights and obligations under this AGREEMENT that by their nature extend beyond the terms of this AGREEMENT shall survive any expiration or termination of this AGREEMENT and shall remain in effect until complete performance thereof has occurred.

18 Successors

This AGREEMENT shall be binding upon and insure to the benefit of Parties and their respective heirs, successors, permitted assigns and representatives.

19 Waiver

No waiver, delay, indulgence or failure to act by either party regarding any particular default of omission by the other shall affect or impair any rights or remedies regarding that or any subsequent default or omission that are expressly waived in writing.





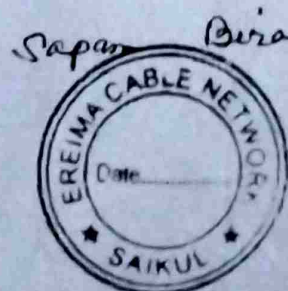

Annexure- 1

Definitions

1. 'Subscriber' means any person/entity who subscribes to Company services rendered through the RailWire initiative. Subscribers shall be construed accordingly.
2. 'LCO' means Local Cable Operator LCOs shall be construed accordingly.
3. 'MSO' means Multi Service Operator. MSOs shall be construed accordingly.
4. 'Level-1' or 'L1' shall refer to support services provided to Subscribers or Software Applications wherein the reported incidents get resolved at the contact centre support personnel level.
5. 'Level-2' or 'L2' shall refer to support services provided to Subscribers or Software Applications wherein the reported incidents require system equipment configuration or reconfigurations/minor servicing etc., to be done by specialists.
6. 'Level-3' or 'L3' shall refer to support services provided to Subscribers or Software Applications wherein technical flaws / faults / snag identified in the System / equipment which is beyond repair by configurations /minor servicing. The equipment would require OEM (Original Equipment Manufacturer) support or replacement and software system would require bug fixes or custom development to fix the issue.
7. 'SLA' means Service Level Agreement, wherein a party providing service quantifies their service levels for measurability of their service delivery performance. '24x7' shall mean 24 hours a day and 7 days a week throughout the year.
