I have the honour to report that, on 05/05/2023 at around 8:30 am, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house and completely destroyed the house and looted much of my properties located Lengdaba Khun, Daili village, PS – Kangpokpi, District - Kangpokpi.

The properties that were dismantled/looted are as follows:

- i. Semi pucca House – Rs. 20,00,000/-
- ii. Outdoor house – Rs. 18,000/-
- iii. Grocery store (wood) – Rs. 3,00,000/-
- iv. Mechanic electrical tools – Rs. 5,00,000/-
- v. Household materials – 7,40,000/-
- vi. Utensils – Rs. 2,00,000/-
- vii. Cash & Jewelry – Rs. 4,40,000/-
- viii. Garments – Rs. 3,50,000/-
- ix. House construction materials – 3,20,000/-
- x. Grainery – Rs. – 50,000/-
- xi. Grocery store items – Rs. 3,00,000/-
- xii. Domestic animals (dog 2 nos. & cat 2 nos. – Rs. 17,000/-) (Duck & chicken 25 nos. – Rs. 26,000/-)
- xiii. Electrical items – Rs. 75,000/-

Total approximate value is about Rs. 53,36,000/- approximately.




Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.
