I have the honour to report that, on 05/05/2023 at around 8:30 am, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house and completely destroyed the house and looted much of my properties located Lengdaba Khun, Dalli village, PS – Kangpokpi, District - Kangpokpi.

The properties that were dismantled/looted are as follows:

- i. Semi pucca House – Rs. 20,00,000/-
- ii. Goat shed – Rs. 12,000/-
- iii. Goat 7 nos. Rs. 1,40,000/-
- iv. Furniture – Rs. 3,50,000/-
- v. Utensils – Rs. 1,50,000/-
- vi. Garments – Rs. 1,30,000/-
- vii. Jewellery (8 SAN) – Rs. 1,20,000/-
- viii. Cash – Rs. 1,50,000/-
- ix. Electrical items – Rs. 80,000/-
- x. Carpentry items – Rs. 18,000/-
- xi. Duck 14 nos. - Rs. 9,000/-
- xii. Hen – Rs. 11 nos. – Rs. 7,000/-
- xiii. Other essentials – Rs. 50,000/-

Total approximate value is about Rs. 32,16,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
