I have the honour to report that, on 05/05/2023 at around 8:30 am, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke household items which is kept at the rented house of Haopu and burned all the household items located Lengdaba Khun, Daili village, PS – Kangpokpi, District - Kangpokpi.

The properties that were burned down are as follows:

- i. Furniture – Rs. 1,28,000/-
- ii. Garment – Rs. 2,50,000/-
- iii. Utensils – Rs. 1,50,000/-
- iv. Electronic – Rs. 30,000/-
- v. Jewellery – Rs. 1,50,000/-
- vi. Paddy (rice) 25 bags – Rs. 37,500/-
- vii. Phisakol/tailoring machine – Rs. 37,000/-
- viii. Cylinder/stove – Rs. 13,000/-
- ix. Pig 5 nos. – Rs. 1,50,000/-
- x. Syntax/firewood – Rs. 23,000/-
- xi. Weaving tread – Rs. 10,000/-
- xii. Weeding arrangement (cash) – Rs. 2,00,000/-
- xiii. Books/MORA/Roofing Tin – Rs.28,000/-
- xiv. Documents (certificate (X & XII), Auto Rickshaw RC Book, Aadhar, ATM 4 nos., pension book, bank passbook 6 nos., voter card 2 nos. and PAN card 2 nos.)

Total approximate value is about Rs. 12,06,500/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
