Today, the 21st January, 2022 at 2:40am received a reliable information that on the same day at about 2:30am some filled tankers and loaded trucks proceeding towards Imphal were pelted stone by unknown miscreants suspected to be the volunteers against the death of Paokhosei Chongloi with reference to FIR NO.5(1)2022 KPI-PS U/S 279/304-A IPC at Keithelmanbi village on NH-02. As a result, some drivers received serious injuries on their persons and evacuated to hospital for medical treatment and some vehicles got badly damaged.

Hence, a suo-motu case under FIR NO. 8(1)2022 KPI-PS U/S 148/149/336/338/427 IPC has been registered for investigation.
