I have the honour to report that, on 05/05/2023 at around 5:30 pm, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house which was located at Kalapahar High School, PS – Kangpokpi, District - Kangpokpi.

The properties that were Vandalized are as follows:

- i. House Vandalized – Rs. 10,00,000/-
- ii. Furniture – Rs. 2,00,000/-
- iii. Utensils – Rs. 50,000/-
- iv. Clothes/Garments – Rs. 1,00,000/-
- v. Electrical appliances – Rs 80,000/-
- vi. Jewelery – Rs 2,00,000/-
- vii. Gas Cylinder – Rs 7000/-
- viii. Gas Stove- Rs 4000/-
- ix. Water Tank(Syntex 2nos.) – Rs 7000/-

Total approximate value is about Rs. 16,48,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
