Sir,

I, the undersigned, have the honour to lay a few lines to take up necessary legal action and steps against some unknown kuki miscreant of Keithelmanbi, P.S. Kangpokpi, Kangpokpi District.

That, I am now serving as Electrician at J.N.V. Kangpokpi since 2016. On 03-05-2023 I am returning home from J.N.V. Kangpokpi at about 7:00 p.m. by riding my two wheeler vehicle Hero Pleasure, bearing Registration No. MN01C 7021, Engine No. JF-16ECDGA18913, Chassis No. MBI JF16EFDGA19837, Black in colour. While I am reaching at Keithelmanbi some unknown miscreants of Kuki beaten me. As a result I was seriously injured and my left hand was fractured and on 08-05-2023, I was undergone medical treatment at RIMS Hospital, Imphal. After some days, I heard that my vehicle Hero Pleasure was burned down by the said unknown kuki miscreants. And on I was discharged on 17-05-2023 from RIMS Hospital.

It is, therefore prayed that the Hon'ble Sir be pleased take up necessary legal action and steps against the unknown kuki miscreant of Keithelmanbi in the interest of justice.
