(4) 2 Bed + Sofa set (5) Mattress Kingsize Blanket (6) Utensils + Electronic Equipments (7)
Gold San 10 (8) Cash 30 thousand (9) Traditional Clothes and Garments etc worth of 21 Lakh
(Twenty one Lakh) approximately.
