- 6. Jewelery 10-Mohor gold (necklace-2, bangle-2, earrings -4 etc.) approx.. 8,00,000/-
- 7. Cash in money Rs. 1,00,000/-
- 8. Important documents were destroyed

Total value is about Rs. 24,90,000/- approximately.
