Subject: Request to register FIR against Jayenta Loukrapam Aka Tapta s/o (L) Bijooy  
Lourakpam of Naransaina Mamang Leikai Moirang, Sub-Division-Reg.

Sir,

Much obliged to inform you that one Jayenta Loukrapam known by his stage name "Tapta", a popular Meitei singer base in Imphal, released a controversial song on 07/07/2023. It is also informed to you that; the lyrics of the above-mentioned song contains lines such:

1. "Meiteis will never have peace until every Kukis are killed",
2. "What you (Kuki Community) want is a homeland, what we desire is your soul",
3. "Once the Army release their grip, the Kuki community shall be eliminated",
4. "Even if the dialogues are made and peace returns, Meitei will not stop this War".

Nevertheless, such kind of message creates perpetual enmity between the Kuki community and the Meitei community and must be punished accordingly in the interest of justice.

It is also pertinent to mention that the singer is categorically accusing that, the Indian army is involved in poppy plantation. One of the lines in the above-mentioned song says, "They (The Indian Army) let them (Kuki community) farm poppies, and share the profit, making them (Army) take their sides". Thus, the statements made in the song against the Indian Army tantamount to defamation.

It is therefore urged to immediately register an FIR against Jayenta Loukrapam Aka Tapta and book him according to law for the interest of justice.
