Sir,

I have the honour to report that today i.e. on 03/02/2023 at around 10:20 am, a joint team of Kangpokpi District Police, NAB, IRB, Forest Department, SDM (Executive Magistrate) Kangpokpi, numbering about 129 (one hundred and twenty nine) persons led by Shri. L. Sheiwing Khongja, MDC, DSP (G.SPM)/KPI, Kangpokpi under the supervision of Shri. Ph. Vikramjit Singh, MPS, SP/KPI, was deputed to carried out a mass destruction of illicit Poppy plants cultivation in the hill ranges of P. Gogang village under Saikul Sub-Division, Kangpokpi District, Manipur about 11 Kms west from the Saikul police station. As per destruction order issued by SDM (executive Magistrate) Dtd. 3/02/2023 the combined teams destroyed about 30 (thirty) acres which were cultivated in hill ranges of P. Gogang village under Saikul police station, Kangpokpi District, Manipur. The expected yields per acre is 10 kgs. The approximate value of the destroyed poppy plantation is calculated at Rs. 2,10,00,000/- (Two crore ten lakhs).

Hence, a regular case under FIR No. 9 (02) 2023 SKL-PS u/s 18 (b)

ND & PS has been registered for investigation.
