Sir,

I have the honour to report that on 03/05/2023 the alleged Kuki community supported by the sophisticatedly armed Kuki militants, indulging in Narco-terrorism, mercilessly attacked the Meiteis inhabited in Torbung Bangla in Bishnupur District, thereby causing deaths of innocent people and burning many houses, on the sidelines of the Tribal Solidarity Rally at Churachandpur District, against the Meiteis for listing in ST list; communal riot between Meiteis and Kuki broke out. The under noted vehicles were deployed in road construction from Harrupkhopi to Rijartaher under Kangpokpi Block of Senapati District under pakage no. MN06376. The said vehicles were overpowered by the heavily armed Kuki militants and stole them from the construction site and could not be traceable till date.

The lists of the vehicles are as follows:

1. Tata Tipper bearing registration no. MN0-4A-7477 having Engine no. 143768 and Chassis No. 360096MT0134446 (The approximate value of vehicle is Rs. 3,00,000/-),

2. Tata Truck bearing registration no. MNP-7626 (The approximate value of

vehicle is Rs. 3,00,000/-),

3. Road Roller bearing registration no. MN01-9402 (The approximate value of

vehicle is Rs. 3,00,000/-) and

4. Bull Dozer bearing registration no. MN04-2301 having Chassis no. D50A15 and Engine no. 25103355 (The approximate value of vehicle is Rs. 15,00,000/-).

So, I therefore, requested you to kindly trace out and recover my vehicles at the earliest and take up necessary legal against the culprit according to law.
