In the meantime some arm kuki militants stopped my vehicle along Dimapur road in between Kangpokpi Bazar and 22nd Assam Rifles camp, (C-Coy), P.S / Dist:- Kangpokpi, Manipur P.S / Dist:- Kangpokpi, Manipur and the said kuki militants threaten to me by using arms and looted/snatching the said my vehicle without any reasons in c/w the present incident (Clashes between Meitei and Kuki) and left the spot. I was unable to report timely to police due to searching my looted/snatched vehicle and my further treatment. The said vehicle is amounted to Rs. 25,00,000/- (twenty five lakhs) Apprx.

It is therefore, kindly take up and further necessary legal action against the said culprits.
