Officer-in-charge Kangpokpi Police Station Kangpokpi District, Manipur Kangpokpi District, Manipur Today i.e. the 10th March, 2023 at 12:30.am received a reliable information that on the same day at @ 11:00 am unauthorized mass rally was organized by Kuki Inpi, Kangpokpi (Apex body of Kuki Tribes) and Kuki Student organization, Kangpokpi District, Manipur at Thomas Ground, Kangpokpi to declare their resentment against the law of the present government violating Sub-section 2 of Section 144 Cr.PC. 1973 imposed by ADM, Kangpokpi. In the meantime combined police team led by SP-Kangpokpi tried to talk to them for amicable solution but the angry mob paid no heed. A mob of men and women started agitation by shouting and pelted stone towards our police party in which some police personnel, CDO and IRB personnel including Sir Th. Vikramjit Singh, MPS, SP-Kangpokpi got sustained serious injuries on their persons. In order to disperse the angry mob the police party, CDO and IRB personnel fired out some rounds of Teargas smoke, Capsi Grenade, INSAS Rifles, AK-47 and MP-5 and 9 mm ammunition in the air to disperse the mob with the permission of Shri Lhunkhopao Touthang, SDC(HQs)/EM, Kangpokpi(Magisterial duty).

Hence, a Suo-Muto case is registered under FIR NO. 9(3)2023 KPI-PS u/s 147/148/149/188/325 IPC for smooth investigation.
