I the undersigned have the honour to state that on 05/05/2023 at @ 4:30 pm, a large number of unidentified people belonging to the Kuki Community with deadly weapons storms at our rented house owned by one Maisnam Robindro Singh S/o M. Khamba Meitei located at ward no. 17 Shanti Veng, Kangpokpi and looted all the valuable household items belonging to me and enclosed on a sheet of paper. In the unfortunate incident, I have lost a total amount of about Rs. 10,80,000/- (Ten Lakhs and eighty thousand only).

It is therefore you are requested to take legal action against the persons involved in the incident for the interest of the justice.
