Sir,

With due respect, I have the honour to report the following few lines that, I am a residence of Kangpokpi ward no. 7, P.O. & P.S. Kangpokpi, District Kangpokpi. On 03/05/2023 at around 7:30 pm large number of unknown person suspected to be Kuki militants & kuki rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house. In that, I along with my family members have come out from my house and stay at my another house located at Sagolband Tera Loukrakpam Leikai, by keeping my house under locked and Key. On 05/05/2023 it comes to light that, the Kuki arms militant & kuki rioters had trespass my house and looted my household properties i.e furniture items, kitchen items, utensil items, clothing, electronics items, jewelry, cash & one two wheeler (Jupiter) B/No. MN01AH-8058 by breaking the Lock and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs. 25,00,000/- (Rs. Twenty five lakhs) approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
