Sir,

With due respect, I have the honour to report the following few lines that, I am a residence of Kangpokpi ward no. 17, P.O. & P.S. Kangpokpi, District Kangpokpi. On 03/05/2023 at around 7:30 pm large number of unknown person suspected to be Kuki militants & kuki rioters with knives, sticks, iron rods, weapons sharp objects etc. broke into my house and vandalized/looted my household properties i.e furniture items, kitchen items, utensil items, clothing, electronics items, jewelry & cash by breaking the Lock and key which I had locked and also killed my dog (breed Labrador). The approximate value of looted & vandalized properties are estimated at Rs. 40,00,000/- (Rs. Forty lakhs) approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
