With due respect, I have the honour to report the following few lines that, I along with my family members staying at the rented house of one Mr Kamlun located at Kangpokpi opposite to Kangpokpi Police Station since last 5/6 years back. However on 3rd May, 2023 at around 7:30 pm, large number of unknown persons belonging to Kuki community by holding deadly weapons and sophisticated backed/supported by suspected armed kuki militants who stormed Meitei/Meetel inhabited areas and villages. The said unknown armed group had trespass my rented house and vandalized many household properties, looted many valuable properties like furniture items, kitchen items, utensil items, clothing, electronic items, cash i.e Rs Twenty Thousand. The approximate value that were looted/vandalized of my property is about Rs Seven Lakh.

There is delay in filing the application as I along with my family members were fleeing for survival and we are currently taking shelter at NSCB (Residential School) Lamboikhongnagkhong, Imphal West.

In this connection, I humbly request you to kindly initiate and take up necessary legal action against the above mentioned culprits.

For this act of kindness, I shall remain ever grateful to you.
