With due respect, I have the honour to report the following few lines that, on 4th May, 2023 at around 11:00 am, large number of unknown persons belonging to Kuki community by holding deadly weapons and sophisticated arms, backed/supported by suspected armed kuki militants who stormed Meitei/Meetei inhabited areas and villages. The said unknown armed group had trespass my house and looted many valuable properties like furniture items, kitchen items, utensil items, clothing, electronic items, 3 cows, 50 no's of paddy rice bag, Gold, cash i.e Rs Forty Thousand and others household properties. The approximate value that were looted/vandalized of my property is about Rs Twenty Five Lakh.

There is delay in filing the application as I along with my family members were fleeing for survival and we are currently taking shelter at NSCB (Residential School), Lamboikhongnagkhong, Imphal West.

In this connection, I humbly request you to kindly initiate and take up necessary legal action against the above mentioned culprits.

For this act of kindness, I shall remain ever grateful to you.
