Sub:- Report.

Sir,

I have the honour to report that today i.e. 5th January, 2024 at about 2.00 p.m. received a reliable information about the presence of some anti-social elements with an intent to commit pre-judicial activities like extortion of money from the general public in and around Mantripukhri bazaar, Imphal East District. Based on the said information, teams of CDO/IE Unit along with a team of HNG/PS Unit and a column 4 AR conducted a mobile random frisking and checking to the suspected passersby at Mantripukhri Bazar.

In that, one suspected person was detained for checking and verification. On checking his body, one mobile phone and one wallet containing a sum of Rs. 6900/- (six thousand nine hundred rupees) and one AADHAR Card were found and recovered from his possession. On verification, the detainee identified himself as one **Aheibam Amorjit Singh (50 years) S/o A. Thoiba Singh of Kongba Kshetri Leikai, Imphal East District** an active member of the outfit RPF/PLA. On further examination, the detainee disclosed that on the advice and instruction of one active member of RPF/PLA through mobile phone, whose phone no. **(8730026218)** is being save as "**N**" in his mobile phone, he had extorted money from the auto-rickshaw plying at NH-2 road. He further stated that the above recovered money i.e. Rs. 6,900/- (six thousand nine hundred rupees) were extorted today from the auto-rickshaw driver plying between Mantripukhri Bazar and Nagamapal at NH 2.

So, the detainee was arrested from the spot i.e. Mantripukhri Bazar at 3.15 p.m. by observing necessary formalities. The above recovered mobile phone (Redmi Go) bearing IMEI no. 863982043567499/01 along with one Jio SIM card having no. 7005748755 and one wallet containing a sum of Rs. 6900/- (six thousand nine hundred rupees) and one AADHAR card were seized from the possession of the arrestee **Aheibam Amorjit Singh** by observing due formalities from the spot i.e. Mantripukhri Bazar at about 5.25 p.m.

Therefore, the arrestee along with the seized items are being handed over to you for taking further necessary legal action against him.
