Subject : Request to take necessary legal action against the unknown armed miscreants.

Sir,

I have the honour to state the following few lines for kind perusal and further necessary action.

That, my husband is running a brick field at Pangei Chingkhui, Imphal East District under the banner "Epa Chingkhulakpa Brick Field" since some years back.

That, on 06/01/2024 at about 2:30 pm, some unknown persons (youth) numbering about 8 (eight), armed with sophisticated/deadly weapons came to our brick field in a Maruti Gypsy (white in colour and without registration number) and called out three workers. They forcefully took away their mobile numbers and photograph in their (armed youth's) mobile phone without the consent of the workers. Further, they demanded a huge amount of money to be handed over within a short period, at a place which would be notified later. They also threatened that if we fail to deliver the demanded money within their notified period they will attack our family with fire arms and bomb at any time. They also gave a mobile phone number - **9089774234** for further contact/conversation. When I tried to contact to the said mobile number, they only demanded a huge amount of money but could not converse in a normal way as they always kept on threatening my family with dire consequences. In such critical condition, my family could not live in peace and my children are not able to go for their study also. It can be mentioned here that, my husband is also out of station for his medical treatment. In such a situation, I am helpless and mentally disturbed and the only way is to seek necessary action from law enforcing agency of the land i.e. Manipur Police Department.

It is, therefore, requested kindly to take necessary legal action against the unknown armed miscreants at the earliest possible.

For which act of your kindness, I shall remain grateful to you.
