Sub:- Report.

Sir,

I have the honour to report that today i.e. 5th January, 2024 at about 4:00 p.m. received a reliable information about the presence of some active members of the outfit KCP (Noyon) at Shangakpham bazar, Imphal East District. Acting on the said input, teams of district police Imphal East led by Inspt. Kh. Henery Singh, Officer-in-Charge Commando Imphal-East Unit and Inspt. Kh. Pathou Meetei, OC/HNG-PS/IE under the overall supervision of Shri. Dr. S. Ibomcha Singh MPS, Superintendent of Police Imphal East District rushed to the said area and conducted a search operation at Shangakpham Bazar.

In that, the combined teams detained one suspected person for verification. On checking his body one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one **Md. Imtiyaz Khan @ Angouba (21 years) S/o Md. Tajao of Kairang Mayai Leikai, Imphal East** an active member of the outfit KCP (Noyon). He further stated that he is presently working under the command of one Thokchom Romeshchandra Singh of KCP (Noyon) and on the advice of the said Romeshchandra he had extorted money from a Pharmacy shop at Sangakpham Bazar. He further stated that he along with the said Mr. Romeshchandra and one Md. Salim of their outfit extorted money from a shop and an office situated at Mantripukhri Bazar about three months before. So, the detainee was arrested from the spot i.e. Sangakpham Bazar at 5:10 p.m. and seized one mobile phone (Redmi Y3) bearing IMEI no. 864471045974613 & 864471045974621 along with one Airtel SIM card bearing no. 9362899857 from his possession at the spot i.e. Sangakpham Bazar by observing due formalities at 5:20 p.m.

On further verification of the arrestee, it came to learnt that his associates (Romeshchandra and Md. Salim) are waiting for him at Kairang, Imphal East. Immediately, our combined team along with the arrestee rushed to Kairang Mayai Leikai and on the pointing of the arrestee (Md. Imtiyaz Khan) arrested one **Thokchom Romeshchandra Singh @ Ayangba (33 years) S/o (L) Th. Nilachandra Singh of Phubala Awang Leikai and one Md. Salim (30 years) S/o (L) Md. Salam of Kairang Mamang Leikai, Imphal East** from Kairang Mayai Leikai at 5:45 p.m. and seized one motor-cycle (Bullet - Royal Enfield) bearing regd. no. MN-01AF/7139 bearing Engine no. U3S5C2KA363345 and Chassis no. ME3U3S5C2KA387845 and two nos. of mobile phones i.e. (i) one mobile phone (Redmi 9) bearing IMEI no. 869241058536293 & 869241058536301 along with one Jio SIM card having no. 7005892815 and (ii) one mobile phone (Carvaan) bearing IMEI no. 359885580967686 & 359885580967694 along with one Airtel SIM card having no. 9233903729 from the possession of the arrestee Thokchom Romeshchandra Singh at the spot i.e. Kairang Mayai Leikai by observing due formalities at 5:55 p.m.

On further verification, both arrestees (Thokchom Romeshchandra Singh & Md. Salim) admitted that they had extorted money from a shop and an office situated at Mantripukhri Bazar about three months back along with the first arrestee Md. Imtiyaz Khan. Further, the arrestees Th. Romeshchandra and Md. Salim, they stated that on the advice of the said Mr. Bobby of KCP (Noyon), they had extorted money from a Scrap shop at Mantripukhri Bazar, an Oil Pump located at Chingmeirong, a tiles/marble shop at Thangal Bazar in the month of July, 2023.

Further, on verification of the arrestee Thokchom Romeshchandra Singh, he stated that he joined the outfit KCP (Noyon) in the year 2007 through one Mr. Hitendra and got his basic military training in the same year under army no. 365 and presently holding the rank of S/s – Sergeant of KCP (Noyon). He further stated that he is presently working under the command of one s/s – Finance Deputy in Charge, Mr. Bobby of KCP (Noyon).

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal procedures.
