

**LODGING OF FIR AGAINST MEIRA PAIBIS AND JCB OPERATORS
PERTAINING TO INCIDENT AT SABUNKHOK KHUNOU VILLAGE**

1. Security Forces columns are deployed on Internal Security Duty in general area Sabunkhok Khunou village in accordance with the requisition of State Government for protection of civilians and maintaining peace in the area. In the past, alleged Meitei miscreants, who have been vehemently opposing this deployment and demanding removal of Security Forces columns from Sabunkhok Khunou brick factory, have fired from brick factory towards Kuki villages of Twichin, Phaimol and Saibol.
2. On 14th Jan 2024, input was recd regarding the movement of unlawful assembly of Meira Paibis towards brick factory, which was promptly shared with SP Imphal East, BSF and CRPF. SP Imphal East was requested to dispatch RAF, at the earliest. In the meanwhile, the location was adequately reinforced by Security Forces columns. At around 1100hrs, strength of around 250 agitated and riotous Meira Paibis aggressively marched towards brick factory. They were initially stopped by police, 150 m short of brick factory, however, the unlawful assembly of Meira Paibis swelled to approx. 800 within no time.
3. The Security Forces columns persistently tried to negotiate with the violent mob, however, the agitated and riotous mob, with clear and specific intent to obstruct the public servants from discharge of their official duty, physically assaulted the Columns of Security Forces by unlawful use of force. Security Forces maintained restraint and calm throughout the event. Thereafter, the unlawful assembly moved out of the brick factory and further gathered 200m away on the exit road, wrongfully restraining the Security Forces from proceeding in any direction.
4. Further, when the Security Forces attempted to move out of the brick factory, it was found out that the road had been unlawfully dug by a JCB, resulting in mischief causing damage to public property, and unlawful restraint on the movement of the Security forces.
5. The activities of Meira Paibis and JCB operators in general area Sabunkhok Khunou brick factory on 14 Jan 2024 were unlawful, violent, and amounted to several cognizable offences under the Indian Penal Code (IPC), 1860 and Prevention of Damage to Public Property Act, 1984. They obstructed the public servants in discharge of their official duty, assembled unlawfully and riotously, intimidated and threatened the security forces and the villagers. The said rioters may immediately be identified and arrested to prevent them from giving effect to their criminal intent and conspiracy.

6. Further, it is requested that FIR against unknown/ unidentified rioting Meira Paibis & other rioters in general area Sabunkhok Khunou village may be lodged for the following offences :-

- (a) Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to **Section 353, 503, 504, 505 and 506 of the Indian Penal Code, 1860.**
- (b) By voluntarily obstructing any public servant in the discharge of his public functions contrary to **Section 186 of the Indian Penal Code, 1860.**
- (c) By disobedience to an order lawfully promulgated by a public servant, if such disobedience causes obstruction, annoyance or injury to persons lawfully employed contrary to **Section 188 of the Indian Penal Code, 1860.**
- (d) Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to **Sec 34, 120, 350, 353 and 332 of the Indian Penal Code, 1860.**
- (e) Instigating and abetting the Unlawful Assembly of rioting Meira Paibis and locals to obstruct the Army in performance of their lawful duty on 14 Jan 2024 contrary to **Section 34, 120, 353, 505 and 147 of the Indian Penal Code, 1860.**
- (f) Assault or criminal force otherwise than on grave provocation contrary to **Section 352 of the Indian Penal Code, 1860.**
- (g) By assaulting or using criminal force to any person being a public servant in the execution of his duty as such public servant, or with intent to prevent or deter that person from discharging his duty as such public servant contrary to **Section 353 of the Indian Penal Code, 1860.**
- (h) By intentionally insulting with intent to provoke breach of peace contrary to **Section 504 of the Indian Penal Code, 1860.**
- (j) Rioting while being armed with a deadly weapon or with anything Which if used as a weapon is likely to cause death contrary to **Section 146, 147, 148 and 149 of the Indian Penal Code, 1860.**

7. Further, it is requested that FIR against unknown/ unidentified JCB operators in general area Sabunkhok Khunou village may be lodged for the following offences :-

- (a) Committing mischief with intent to cause destruction of any property or any such change in property as destroys or diminishes it's value contrary to **Sec 425 of the Indian Penal Code, 1860.**
- (b) Committing mischief by injury to public road contrary to **Sec 431 of the Indian Penal Code, 1860.**


(c) Committing mischief by causing damage to public property contrary to Sec 3 of Prevention of Damage to Public Property Act, 1984.

(d) Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to the aforementioned provn incl Sec 186, 353, 503, 504, 505 and 506 of the Indian Penal Code, 1860.

8. The Hon'ble Supreme Court in Lalita Kumari Vs Govt of UP (MANU/SC/1166/2013) has held "It is mandatory to file the FIR u/s 154 of the Code if the information discloses the commission of a cognizable crime and no preliminary investigation is permissible in such a case". In deference to the Hon'ble SC ruling, you are requested to register a First Information Report against the above mentioned persons.

9. It is requested that action taken post registering of FIR and identification as well as initiation of legal action in respect of perpetrators of above crimes be intimated in laid down time frame (without waiting for invoking of the provisions of the Right to Information Act, 2005). A copy of the FIR, and the police report on completion of the investigation in terms of Section 173 (2)(ii) of the Criminal Procedure Code, 1973 may please be provided to this office for our records please.


