Today i.e 14/01/2024 at 06:30 pm, received an information that, on the same day at around 06:20 pm, one Honda Amaze car white in colour bearing Regd No. MN05A-5988 which was coming from Kontha Ahallup towards Sangakpham side collided with one two wheeler vehicle Duro 125DZ maroon in colour bearing registration No. MN06SA-5231 which was coming in opposite direction i.e. Sangakpham towards Kontha Ahallup side in front of Manipur Gas Godown Paomei Colony, due to rash and negligence driving on the part of both the driver/rider of Honda Amaze car and Duro 125DZ. As a result, both the rider and co-rider of two wheeler got injured and evacuated to Hospital for medical treatment and both the vehicles were also damaged.
