Subject : Request for registration of complain against I.T.L.F., COTU and Kuki Militants groups for attacking and burning movable and immovable items and take necessary arrangement to compensate for such lost items of Youth Paradise Club Gwaltabi, Imphal East, Manipur.

Respected Sir,

With due respect, we the undersigned have the honour to state the following few lines for your kind consideration and take necessary legal Process to punish and compensate all lost movable and immovable items that,

from 3rd May 2023 there was a mass rally organised by Kuki Organisation at Churachandpur in which rally many Kuki used bad local languages and finally that rally turn into violence and many Meitei 's houses were burnt down and attacking upon Meitei Community. Such attacking upon Meitei by Kuki Communities backed by ITLF, COTU and Kuki Militants spread like wild fire reached upto Moreh, Kangpokpi, Motbung, Ekou, etc. On hearing and seeing such attack we, residents of Gwaltabi left our vilage and took our shelter at our relatives residences and neighbouring vilages like, Yaingangpokpi, Sabungkhok, Seijang, Leimakhongoal etc. Because of fear we did not sided all properties of Youth Paradise Club Gwaltabi, Imphal East, Manipur to safety area. On 28th May 2023, on this day there was a heavy attacked by kuki militants at Gwaltabi area like Sanasabi, Sabungkhok Khunou, Thamnapokpi, Yaingangpokpi, Santikhongbal. In which the following items of Youth Paradise Club, Gwaltabi were totally burnt down by Kuki terrorist.
