I the under signed have the honour to state that today i.e. 03/02/2024 at about 4:00 pm while I was residing at my home a reliable information was received that my daughter namely Kangabam ningol Yaikhom ongbi Chandrima Leima aged about 27 years was found hanging at her husband (Yaikhom Nongdamba Meitei) house located at Chanung Awang Leikai, Imphal East District, Manipur. In the meantime, my late daughter told me that, she was assaulted by her husband and also cruelty and abuse by husband and mother in law (Yaikhom ongbi Bimo). So, the death of my daughter is highly in suspicious,

I therefore, requested to kindly taken up legal action against the above mentioned persons.
