Sir,

As endorsed, I have carried out minute enquiry in c/w the above ref. GD.Entry No. arising out of complaint report lodged by one Ashang Kasar s/o Athing Kasar of Nagaching, Lamlongei, HNG-PS/IE with OC/HNG-PS/IE on 22-01-2024 stating that on 16th January 2024 at @ 6:00pm he received a whatsapp message from Shri. Letsei Haokip, Churachandpur through mobile phone No. 8729885022, a member of Kuki-Zo volunteers whose full particulars are concealed, addressing to Tangkhul brothers by threatening him and also challenging the Naga Community. (the Whatsapp message is enclosed herewith).

The allegation made by anonymous Kuki-Zo Volunteers in the said whatsapp message are all concocted and conspiring to defame the applicant within his community and to create enmity among the communities in the state.

Therefore, he have a strong apprehension for loss of many lives if ignited in consequences of the said message received on the aboved mentioned date through Whatsapp. Such threatening message of Kuki-Zo Volunteers clearly seen intentional insult with intend to provoke breach of peace between the communities and by person to the applicant. Hence, the case.

That, during the thorough enquiry it is found to be genuine and it is also learnt that the complainant continued to received other various life threatening whatsapp message from the above mentioned phone no. i.e. 8729885022.

As such thorough investigation by registering a regular FIR case would be more suitable for the end of justice.
