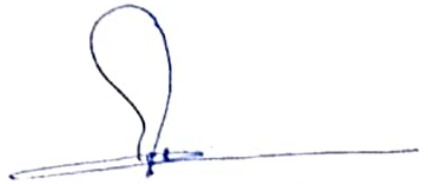

Today i.e. 06/02/2024 at 7:40 pm received a reliable information that on the same day at about 7:30 pm one Royal Enfield (Himalayan) Black in colour, bearing registration No. MN04G 2807 ridden by unknown person coming from Sawombung side towards Imphal and one Activa Silver in colour, bearing registration No. MN01V 8645 ridden by unknown person which was coming from Imphal Side towards Sawombung collided at Chingarel Tejpur near Poloi Tuff ground along NH-202, Imphal-Ukhrul road. As a result of which both the unknown riders and the pillion rider of Activa got injuries on their persons and evacuated to Hospital for medical treatment. Both the vehicles were also partly damaged.

Hence, a suo-mottu case under FIR No. 6(2)2024, LLI-PS U/S 279/338/427 IPC has been registered for investigation.
