Today i.e. 13/02/2024 at around 11:30am received and information that at 11:20 am a heavy exchange of firing took place in between some unknown armed miscreants and kuki militants at the hill ranges of Thamnapokpi Uyok Ching & Twichin village (Kongneh). During the firing incident the police, army personnel posted at Sabungkhok khunnou brick field, Army posted at Simol village and personnel of Yaingangpokpi -PS on duty at Thamnapokpi also retaliated by firing few rounds to intervene / control the gunfight between some unknown armed miscreants and kuki militants the firing continue intermittently till 10:45pm. In this regard OC / Yaingangpokpi PS registered a case under FIR NO. 07 (02) 2024 YPI-PS. U/S- 307/34-IPC & 25(1-C) A. Act. on sou-moto.
