

**DISRUPTION BY MEIRA PAIBIS WHILE ARMY PERFORMING BONAFIDE DUTIES**

1. On 13 Feb 2024 at 1145hrs miscreants attacked Saibol Vill with heavy automatic fire supported by Lathode and 2" mortars.
2. Indian Army column rushed to the said location to defuse the situation. When additional columns were being moved to reinforce the Army troops, they were stopped by large crowd of Meira Paibis at Sabunkhok Khunou, YKPI and Thamnapokpi, though vehicles full of commandos were allowed to cross.
3. The act of Meira Paibis is severe violation of the laws in vogue. Since the additional columns could not search the threatened location, security of the area was severely jeopardised. Blockades by Meira Paibis are hampering the operations of Army and in this type of situation Army will not take any responsibility if there is any damage to property or any life is lost.
