



SUB - LODGING AN FIR.

SIR,

On 13 Feb 2024 at about 2100 hrs. Indiscriminate fire started between VBIG and hill insurgent in the general area of Twitchin or Phymol (Kuki) areas and Santikhombal (Metel) areas. While some bullets seemed to fly close to the BSF post and automatic weapons were being used by both the parties, the entire post was alerted by No 886225645 ASI Ummed Singh (CLO) of BSF camp Yaingangpokpi. The direction of fire was identified and for better assessment of the situation, Sh Atul, AC Coy Commander directed to fire 02 Nos of illu bomb from 51 mm Mortar. Immediately 02 Nos of illu Bomb was fired by No 024015017 Const Raman Kumar Mishra (BUTT NO. 14, BODY NO. L-003427, LOT NO. 693 AODR 08-17). On seeing the illu bomb the insurgents escaped and further fire stopped. Distance from camp appx 400 Mtrs. Direction NW. No casualty/damage of men and material noticed so far.
